Amir is an expert in German and European patent law. He studied mechanical engineering at the RWTH Aachen University (Rheinisch-Westfälische Technische Hochschule Aachen) with focus on production engineering. He has been working in the field of intellectual property since 2009, and completed his training as a patent attorney in an IP law firm in Düsseldorf, at the FernUniversität in Hagen, at the Higher Regional Court of Düsseldorf (Presiding Judge Dr. Thomas Kühnen), at the German Patent and Trademark Office and at the Federal Patent Court in Munich. Amir was admitted to practice as a German Patent Attorney in 2012 and since 2013 he is also a European Patent Attorney.

In 2019 Amir was appointed to the Examination Commission for German Patent Attorneys by the Federal Ministry of Justice and is committed to the training of young patent attorneys.

Before founding the IP law firm Wenzel Nemetzade Warthmüller Patentanwälte Part mbB in 2020, he worked for renowned patent law firms in Munich, where he gained extensive experience in advising domestic and foreign clients.

His professional focus is on drafting patent applications and representing clients in patent and utility model proceedings with the German Patent and Trademark Office (GPTO) and the European Patent Office (EPO). He also coordinates international patent prosecution proceedings for his clients, often involving the management of large patent families and

client portfolios. He has also extensive experience in complex adversarial proceedings and disputes, including nullity proceedings with the Federal Patent Court and infringement proceedings with the German civil courts. He was able to acquire special know-how in this area during his many years of cooperation with the law firm Grünecker Patent- und Rechtsanwälte PartG mbB. A further focus of his legal practice lies in the preparation of expert opinions on infringement and validity of German and European patents. He also advises his clients on license agreements, in the field of employee invention law as well as on trademarks and designs.
